- + An orchestration with a pause step.
- + Processes with time gaps between.
- The pause could be for a long period.


What is it? continued

- Wait for humans or third-party systems to complete tasks.
- + Save all relevant orchestration data in the database.
- Resume the orchestration where it paused or got an error.


What is it? continued

- + Building one orchestration for different processes.
- + Monitoring the process
